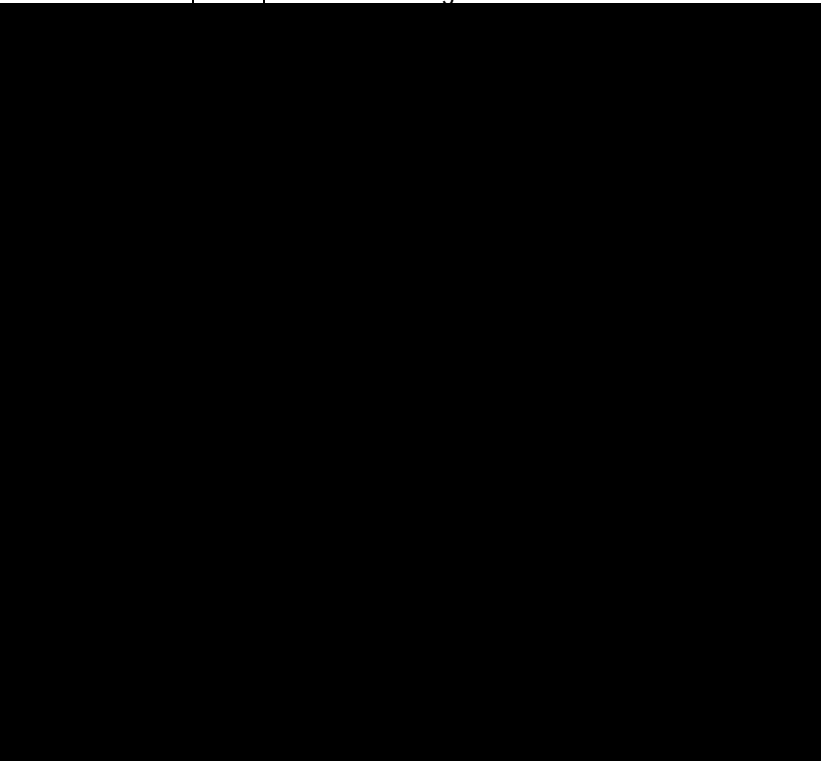

4.3. Medical

Description:

SHSU-COM shall provide access to physical and mental health services that respect each student's right to privacy.

Procedure Step/Task	Responsible Party
1. SHSU will secure the services of licensed mental health care providers and maintain clinic facilities that are dedicated to enrolled students.	SHSU Counseling Center
2. Facilities will provide services during regular business hours but may extend those hours based on course schedules and other factors.	SHSU Counseling Center
3. SHSU will provide 24-hour access to behavioral and mental health services to all enrolled students. Such services will be provided in a confidential manner using both university based, community based, and externally contracted services.	SHSU Counseling Center
4. SHSU-COM will work in cooperation with the Dean of Students Office to identify students demonstrating at-risk behaviors in order to facilitate early student wellness	Dean of Students Office
